LAKE COUNTY ROAD MAINTENANCE MILL LEVY																													
This is a request for a five (5) year mill levy to assist the Lake County Road Department to purchase and maintain; road graders, trucks, road oil and other equipment. This levy will be a maximum of twenty (20) mills per year. A home/property with a \$100,000 market value would pay \$34.12 a year and a \$200,000 market value home/property would pay \$68.24 per year. In the sixth (6) tax year the mill levy would be reduced from twenty (20) mills to five (5) mills creating a permanent levy to maintain existing chip sealed roads. A \$100,000 market value home/property would be lowered to \$8.53 per year. A \$200,000 market value home/property would be lowered to \$17.06 per year.
